Our wheelchairs are always provided at absolutely no cost to those in need of mobility. We had an exciting year! With the help of our supporters, we were able to provide over 77,000 wheelchairs during this past fiscal year. Since 2001, Free Wheelchair Mission has distributed over 930,000 wheelchairs to those with disabilities in developing countries. In addition to wheelchairs, Free Wheelchair Mission donated almost \$3,000,000 of gift-in-kind medical supplies to our distribution partners during the year. These supplies are selected for the purpose of enhancing the utility of our wheelchairs or to support surgery to prevent physical disabilities.
