## Which Gift Option is Best for You?

Empower people with disabilities in developing countries for generations to come through our Legacy Gift options.

### Bequests

Add Free Wheelchair Mission to your will and make a difference in the future while keeping control of your assets during your lifetime. You will have the flexibility to change the gift if your circumstances ever change. Plus, there's no limit on the estate tax deduction for charitable gifts like this, as of this writing.

### Securities

Experience the impact of your gifted assets today by donating stocks to Free Wheelchair Mission. This may also give you a tax break based on the current value of the stocks you donate.

### Real Estate

There are immediate benefits should you decide to donate property like a house or land to provide wheelchairs for those in need. First, you can get a tax deduction right away for the full current value of that property. Plus, you won't have to pay any capital gains tax on the increase in value when you transfer it.

### Life Insurance Policy Proceeds

Empower those living with disabilities in developing countries for years to come by making Free Wheelchair Mission a beneficiary of your life insurance policy.

### Retirement Plan Proceeds

More lives will be transformed when you choose to donate your assets tax free. You could still take withdrawals from the plan during your lifetime and continue to have access to the money you need while also leaving a lasting impact on people with disabilities in developing countries.



### Charitable Remainder Trust

Instead of selling valuable assets like stocks, property, or a business share, you can transfer the assets to a Charitable Remainder Trust (CRT), which is designed to give you income for a specific number of years or even for the rest of your life. You won't have to pay capital gains tax on it, you'll get an immediate tax deduction, the assets in the CRT won't be counted as part of your taxable estate, and you'll be providing life-changing gifts to those in desperate need of wheelchairs.

### Charitable Lead Trust

Give others the gift of mobility while also leaving your loved ones an inheritance. With a Charitable Lead Trust (CLT), you first donate a portion of your assets to Free Wheelchair Mission for a certain period, during which we receive regular payments. After that period ends, the remaining assets are then passed on to your chosen beneficiaries.

### IRA Rollovers

If you're required to take a Minimum Required Distribution (MRD) from your IRA, you may have to report that as taxable income. However, if you give up to \$100,000 from your IRA straight to Free Wheelchair Mission, you will be transforming lives with the gift of mobility without having to pay income taxes on that amount.
